# Statehouse Report

In Columbus, the Ohio FOP has been working daily to protect the interests of you, our members. We focus on legislative issues that have a direct impact on labor, pension and law and order. We have a legislative committee led by Chairman Mark Drum and Legislative Agents Jay McDonald and Jason Pappas. They have a professional legislative consultant to help guide them in Mike Taylor, former Ohio and National FOP Board member and Jay Smith is your full time staff member dedicated to legislative affairs.

In the 128th General Assembly, the FOP has been working on several issues that we will outline below:

- **Pension Reform** - The Ohio Retirement Study Commission mandated all of Ohio's five public pension plans to submit a plan to achieve a 30 year funding level. This level basically means that the plans have to enough assets on hand to cover 30 years worth of expenditures. The only plan to currently meet this legislative requirement is the PERS system. Our members are primarily in the Ohio Police and Fire System (OP-F) and the Public Employees Retirement System (PERS.) The OP-F, the system submitted a plan to get them close to the 30 year level that raised the retirement age to 52 for new hires, delayed the COLA adjustment until members were 55, raised the contribution rates for members and employers, changed from a high three year calculation to a high five year calculation to set your pension, changed the DROP plan from a minimum of 3 years participation to 5 years and lowered the interest guarantee from 5% to 3% for those in DROP and other things.

In PERS, they were not required to change anything since they were already in compliance but they still choose to submit a plan that reduces benefits to members. Raising the retirement age by two years (although they recognize the need for its law enforcement members to stay consistent with OP-F, so if OP-F raises the retirement age, they will to), change COLA from 3% to whatever the consumer price index is with a maximum of 3%, change high three years to high five years to calculate the pension amount, increase amount members need to make per year for it to count as a year of service and some other changes as well.

The Ohio FOP is working to insure that the best interest of the members are the primary consideration for lawmakers when they consider these proposals in 2010, while at the same time realizing that the future viability of all of the pensions systems is everyone's top priority.

- **Issue 3 - Ohio's Casino Initiative.** With the passage of Issue 3, enabling legislation will need to be implemented. This legislation will deal with how best to set up the Gaming Commission, how to utilize the funds for law enforcement training that were part of this issue and other issues important to the Ohio FOP. We will continue to play a role in this important issue that was endorsed by our members in July of 2009.
- **DNA legislation** - The Ohio FOP supports parts of Senate Bill 77 and hopes to improve other parts of the legislation. The provisions we support include the taking of a DNA sample from every felony arrestee, allowing convicted felons the opportunity to obtain DNA testing to prove their innocence even while on parole or probation. We are working to improve the provisions in the bill regarding the way line-ups and photo line-ups are done, the requirements for biological evidence retention and destruction and mandated electronic recording of interrogations in basically all rape and murder cases.

# FOP Fights Layoffs

FOP Lodges and FOP / Ohio Labor Council units are fighting attempts by employers across the state to use the current economic crisis to attack their collective bargaining agreements. Employers are trying to obtain concessions by threatening layoffs of law enforcement officers. Whether or not to take concessions is not something that the State Lodge is going to tell you to do. Those decisions are best made locally. Only you know if there are steps employers can take to minimize the budget shortfalls. Only you know what the long term consequences of concessions are to you and your brothers and sisters.

Those that have been successful in fighting concessions and layoffs have done so because of political might. Publicly support those who support you and challenge those who are being political cowards by applying any budget shortfalls to every department equally, instead of prioritizing any budget cuts. Challenge politicians by asking who will watch sex offenders in your jurisdictions when deputies are cut, who will take drunk drivers off the streets if cops are cut. Stress the fact that politicians are cutting public safety and that affects every member of the community. Be politically active, it is your best bet to keeping everyone employed.

## FOP fights for H1N1 Vaccinations for members



The Fraternal Order of Police of Ohio asked Governor Strickland why law enforcement officers were not on the priority list for those who receive the H1N1 vaccination during a meeting at his office in November.

The Governor responded that the rules were made at the

CDC in Washington but that he understood our concerns.

It was explained that they expect a large shipment of the vaccine in early December and anyone who wants a vaccine should be able to receive it soon.

FOP Lodge 9 in Columbus asked its US Rep. Pat Tiberi to check

with the CDC to see if law enforcement can be added to the list of priority recipients for the vaccine.

We will keep you up to date on this topic. Stay Safe!
