

Section Two Standing Rules

Standing Rules of the Fraternal Order of Police of Ohio, Inc. Annual Conference of 2022

- Rule 1. (a) The Credentials Committee, as the first order of business, shall report the number of delegates and alternates registered as present with proper credentials and shall make a supplementary report after the opening exercises at the beginning of each day that business continues. No other business may be conducted until the Credentials Committee report is adopted by the body.
- (b) A member registered as an alternate may be transferred from alternate to delegate at any time during the business meeting on Monday, July 18th.
- (c) A member registered as an alternate may be transferred from alternate to delegate by 9:30 a.m. on Tuesday, July 19th, for purposes of conducting business on Tuesday, July 19th.
- Rule 2. The standing rules of the conference shall be considered as the second order of business.
- Rule 3. For admission to the conference room where the business of the FOP of Ohio, Inc. is being conducted, delegates, alternates and others shall be required to wear the badge issued by the Credentials Committee upon registration.
- Rule 4. A resolution offered by an individual delegate shall be in writing, signed by the maker and the seconder, each of whom shall be a voting member of the conference, and shall be sent directly to the Chairman of the Resolutions Committee.
- Rule 5. A delegate must obtain the floor and be recognized by the presiding officer before beginning to speak.
- Rule 6. A delegate can speak twice to a motion on the same day, but he or she can take the second turn only after everyone who wishes to speak the first time has spoken. If debate on the motion is continued at the next meeting, which is held on another day, the delegate's right to debate is renewed.
- Rule 7. Speakers must address all remarks to the chair; cross talk between delegates is not allowed.
- Rule 8. Speakers must be courteous and never attack other delegates or question the motives of the delegates. In controversial issues, the discussion is focused on ideas, not personalities.
- Rule 9. All nominations for Office will be made from the floor and will last no longer than three (3) minutes.

Rule 10. GUIDELINES FOR POLITICAL ENDORSEMENTS

- A. In order to be considered to receive a political endorsement for the Fraternal Order of Police of Ohio the candidate must participate in the screening process, which consists of submitting a written response to the FOP questionnaire and participating in the oral interview process conducted by the political screening committee, unless the candidate is unopposed. In that circumstance, the questionnaire may be waived.
- B. The Political Screening Committee (PSC) will provide to the District:
 - A list of candidates requesting an endorsement.
 - A synopsis of any oral interview or communications.
- C. On the second day of the Conference the PSC will make their formal recommendation to the delegates for consideration. This recommendation will be made based on the priorities of the Fraternal Order of Police of Ohio.
 - Included with the PSC recommendation on which candidate to endorse will be an over view validating said recommendation.

This process will allow each District the opportunity to evaluate said recommendation in their caucuses.

- D. In order to avoid any improprieties (such as alternates or guests voting) all votes to issue an endorsement will be taken District by District by the District Trustee and the delegate must be on the floor to vote.
- E. To receive the FOP of Ohio endorsement a PSC recommended candidate must obtain the vote of sixty percent (60%) of the delegates voting.
- F. If the delegation fails to endorse the PSC recommended candidate, no endorsement will be made in that race.

2022 IMMEDIATE PAST PRESIDENT'S REPORT

Good Morning Brothers and Sisters,

I would like to welcome you to the 86th Annual Conference of the Fraternal Order of Police of Ohio, the oldest State Lodge in the Fraternal Order of Police.

We have not met as a State Lodge delegation since 2019. We must remember all of the men and women who have given the ultimate sacrifice since that time. Since July of 2019 and June 24, 2022 when this report was written, 1,237 of our Brothers and Sisters have died in the line of duty. According to the Officer Down Memorial Page, 785 of those deaths are attributed to the deadly COVID 19 virus. In the beginning of this pandemic, the FOP was fighting for access to the vaccine for our members and a recognition that COVID was a work related disease for PSOB and BWC purposes to coping with the disease and knowing that we will have to live with the virus from now on and just adapting to it.

We also lost 152 men and women to gunfire over the same time period. It seems as if the violence against law enforcement officers is at a level we have not seen in decades.

There are so many challenges facing our profession, from increasing violence directed at officers and record levels of violence in our major cities. Recruitment and retention is a major worry of agencies and of individual officers. Officer burnout because of short staffing and mental health concerns of LEO's continue to be major problems. There seems to be more and more elected officials concerned about offenders and less and less concerned about victims. Pension and health care concerns for our members are ever-present. There is one group at the forefront of all of these issues in our state, that is the FRATERNAL ORDER OF POLICE OF OHIO. PERIOD!

I am proud to continue to fight for the members of the FOP here in the Buckeye State. I am grateful that I still am able to play a role in defending cops. Standing up and speaking out on behalf of officers is something that I will never stop doing and there have been plenty of opportunities to do just that since we last gathered in 2019.

We have been passed by the State of Florida in terms of FOP membership and we are now the fourth largest state lodge in the Fraternal Order of Police. While I readily admit that we do not have the growth potential of other states, we must continue to grow our membership whenever we can.

There has been multiple efforts to engage in so-called police reform in the State of Ohio since 2019. We have been able to hold off every major attempt to hold the police responsible for every social ill known to man. An ongoing effort still exists and has the support of the Attorney General and the Governor, that is licensing of law enforcement officers. Those in favor of this effort say it is no different than lawyers, doctors or even barbers who have state licenses. They will say that we need a law to prevent bad cops going from one agency to the next. However, it is much different from our view. The latest version of this effort submitted by the Attorney General would create a statewide internal affairs bureau that could investigate complaints about officers for a wide variety of alleged violations. A new division of employees of the Attorney General could investigate complaints about officers conduct; their health (both physical and mental) if a complaint was made in regard to that; and also allegations of criminal misconduct. These investigations would then be referred to an appointed Board of Law Enforcement to judge the officer/deputy/agent or trooper. This Board could revoke an officers license, thereby ending his/her career...with no appeal to an arbitrator. The appeal would go to the full OPOTA Commission. The proposal also included data collection of use of force incidents, collecting the age/sex/race of the officer who is alleged to have used force. Lastly, it mandated outside prosecutorial review and outside investigation of officer involved shootings resulting in death.

We pushed back hard on this proposal because it included a severe lack of due process. It included a burden of proof that was a "preponderance of the evidence" standard we felt was way too low to take someone's career away. We fought against including any provisions relating to the health of the officer. We insisted on the civilians who would be included on the board to be able to pass a LE background check and the entire board be prohibited from speaking about pending cases/issues. We fought against allowing the board the ability to subpoena records, like medical or cell phone data, for these kinds of investigations. We pushed back on the makeup of the board, arguing for FOP representation and diversity in the kinds of agencies and assignments of the personnel on the board. We demanded that LEO's not lose their salary while the investigation was ongoing.

Almost every one of our suggestions were added to the bill, which caused the AG and the Chief's Association to no longer support the proposal. At a gathering of Chiefs, it was reported the amended proposal was now worse than collective bargaining. However, this issue is not going away and we need to be ready to act to protect our members and I believe we will be prepared to do just that.

These licensing or credentialing proposals are popping up all over the nation. In Michigan, it was reported that they have trouble with the board just sitting on these cases leaving the officer in limbo for years. New Jersey, California, Indiana, Washington and Georgia all have had bills that are similar to the one proposed here in Ohio. There may be others as well.

Healthcare remains a top issue for our membership. The very best way to fix this issue is to establish Medicare at 50 or 55 for 1st Responders. Our members retire about 10 years earlier on average and should be able to access Medicare ten years earlier as well. The FOP of Ohio Board directed our National Trustee, Shaun Laird, to make a motion to the National FOP directing them to make pursuing this legislation a priority. It passed unanimously. Our leaders made this topic a priority with the Ohio Congressional delegation as well in our discussions with representatives and senators as well. We need to make this a priority for our congressional endorsements this year and make health care a top consideration when making endorsements. Health care needs to be fixed in Washington D.C. The FOP of Ohio continue to push national legislative leaders to fix this problem that impacts every single one of our members.

Our members have served in the most difficult of circumstances since we have last met. What some called civil disturbances or social uprisings or peaceful protests, we have called some of these instances flat out riots. These riots took place from Portland, Oregon to Washington D.C. and lots of places in between, including here in Ohio. Our members were forced to work on the front lines of these events and suffered injuries that were both numerous and severe. They had bottles, rocks and other items launched at them. They were sprayed with chemicals. They were battered and bruised. Our politicians gave up our streets and our statehouse. We looked for leadership from elected leaders and found little. We screamed from the rooftops that violence against officers was wrong, should be condemned by everyone and had to stop. It does not matter who assault cops or the reason they are rioting. It does not matter to me which city or state these riots took place in. I STAND WITH COPS. EVERY SINGLE TIME.

I expect that this coming summer will be another of violence and turmoil and the cops will be risking their lives standing in the middle of fanatical people who are willing to commit violence to get their way. I pray for all those who will be risking everything to protect and serve our community.

It seems that the narrative surrounding these attacks on police have begun to fade away, at least from most politicians. While I welcome the change in the narrative, we still have many political challenges as a profession, as a union and as a nation. The juvenile justice system provides way too little justice. We have some who wish to eliminate bail, even for the most serious offenders. We have some who want to give every benefit of the doubt to criminals and none to victims. Those pushing for less consequences for criminals range from the very liberal to the very conservative in an unholy alliance that puts our citizens and our members in jeopardy. One of our members of the Ohio FOP has said over and over again, that cops have the hardest job in America and I completely agree. All of you have my respect and my promise to fight alongside of you!

Lastly, it would not be a Jay McDonald report if we did not talk about Right to Work and collective bargaining. The Buckeye Institute and ALEC and other anti-union groups are still pushing for things like:

"Public Employee Choice Act" and the "Comprehensive Public Employee Freedom Act," which would allow government workers to opt out of union representation and represent themselves in negotiations with their employer.

Other ALEC bills would mandate transparency in union spending to the public and ban "release time," in which a public employee draws a public salary while working on union recruiting and representation activities.

"Union Recertification Act" is what ALEC calls "worker voting rights," workers in unions would have to vote every couple of years on whether they want to continue with their current union representation.

The Buckeye Institute mailed almost every public employee in Ohio advising them they no longer had to belong to the union. They are suing in Minnesota over "exclusive representation" and asking that non-union members be mandated to be on contract teams and committees, etc... They are also trying to get all fair share fees collected before the Janus ruling rebated to the non-payers. The misleadingly named Freedom Foundation has been waging war on public employees, saying in part that employees have a "God-given right" to stop paying union dues.

Always remember: Right to Work is WRONG!!!

2022 FOP State Conference – Independence, OH
July 17 – 19, 2022

Welcome to the Ohio State Conference in Independence, OH— It has been several years since we have met in person. I am looking forward to seeing all of you. The members of the 8th District will be working hard to make sure that the conference goes as well as other conferences from the past. I want to thank all members from the FOP, FOPA, and FOP Auxiliary that will be working to put on the State Conference. I also want to thank the employees at the State FOP and the OLC who are busy throughout the year working for FOP members.

National Trustee Activity – In April, the National FOP hosted the 2022 National FOP Spring Board Meeting in Philadelphia, PA. The National Board also continues to meet by teleconference each month. The monthly teleconferences and publications from the National FOP keep the National Trustees advised of the happenings and communication is greater than ever.

As a member, I encourage each of you to ask to receive the Washington Watch legislative emails, download the National FOP APP, and keep up with the happenings in the National FOP Journal. In addition, President Yoes has started a podcast to discuss police matters. The podcast is called "Blue View by the Fraternal Order of Police" and is available on your mobile device.

My activity report has been recorded and is available upon request.

Updates on Legislation

The Social Security Fairness Act – This legislation would repeal the "Windfall Elimination Provision (WEP)" and the "Government Pension Offset (GPO)" in current Social Security law. As many of you know, employees that receive a public pension do not receive the full amount of their social security earnings. The elimination of this provision has been a top priority of the FOP for years. The goal is to eliminate it, but any relief would be seen as a positive step.

In years past, this proposal would not even get past the committee stage. But, at this time, there are 279 co-sponsors, which is the highest number we have ever had. If we reach the number of 290 co-sponsors, the bill gets moved for a vote.

I realize this is still a longshot. However, it is encouraging to know that we are closer than ever to move forward.

Police Reform Executive Order – In May, President Biden issued an executive order to address police reform. There were only two police groups that got a seat at the table during the discussions: The IACP, and the FOP. The executive order is a far cry from prior action by US Representatives who previously pushed the "George Floyd Justice in Policing" Act through the

house with lightning speed. The FOP was committed to fight any bill that called for the elimination of qualified immunity or changing the Graham v. Connor standard for the use of force.

As time has gone on, the calls for police reform have quieted down considerably. Police reform was a focus on what was never the problem in the first place.

National Committee Appointments – I constantly hear of good work being done by members from Ohio that are on National FOP Committees. I thank all members on committees that are representing our state so favorably.

Recruiting and Retention Across the Country – I continue to hear from agencies across the country concerning the difficulty in recruiting good applicants and retaining valuable employees. This is discouraging as assignments are unfilled and citizens are less safe. We will not see this change except with time and with a commitment from citizens and politicians to focus on making the conditions better for police officers.

National FOP Day on the Hill — Day on the Hill was conducted virtually again this year. Although it has been several months, I want to thank the members from around the state who spend the time to lobby for FOP priorities.

As far as issues within the state, members of Ohio Police and Fire Pension Fund should be aware of HB 512. This bill would increase funding for the pension fund from employer contributions. More will be covered on this bill at the conference. Please be prepared to call your legislators for passage of this bill.

The National FOP APP – Since its inception, the National FOP APP is updated almost every other day and has good information about news concerning the FOP and national media appearances. Please consider downloading the National FOP APP. This APP is for members only.

National FOP Conference Dates

2022 Police Week Report – Police Week was again a success and is so vitally important for all survivor families. I want to thank all members from Ohio that contribute to and attend this event. Opinion

We have audited the accompanying consolidated financial statements of the Fraternal Order of Police of Ohio, Inc. and Subsidiaries (the Company), which comprise the consolidated statements of assets, liabilities and net assets - modified cash basis as of December 31, 2021 and 2020, and the related consolidated statements of support, revenue, expenses and net assets - modified cash basis for the years then ended, and the related notes to the consolidated financial statements.



Notes to Consolidated Financial Statements December 31, 2021 and 2020

Nature and Scope of Business

The Fraternal Order of Police of Ohio, Inc. (FOP), a state lodge chartered by the Fraternal Order of Police, a national police organization, was organized in 1934. The FOP is dedicated to the advancement and protection of law enforcement officers, the promotion of improved law enforcement methods and the teaching of respect for law and order.

Entities that are related to the FOP are as follows:

- **222 Corporation**, a wholly-owned not-for-profit subsidiary that owns the office building where FOP is located.
- The Fraternal Order of Police Ohio Labor Council, Inc. (OLC), a not-for-profit
 organization, is not under the direct control of the FOP and therefore is not consolidated
 with the FOP and Subsidiaries. OLC is dedicated to the betterment of law enforcement
 personnel through the representation of its members in collective bargaining and other
 labor relations matters.
- Fraternal Order of Police of Ohio Foundation, Inc. (FOPF), a not-for-profit organization controlled by the FOP that was formed for the purpose of providing support and financial aid to persons in need, including but not limited to, Special Olympics, Easter Seals, law enforcement personnel in need, survivors of law enforcement officers killed in the line of duty or any other charity as so approved.

Summary of Significant Accounting Policies

Principles of Consolidation

The consolidated financial statements of the FOP and subsidiaries (the Organization) include all accounts of FOP, 222 Corporation and FOPF. All significant intercompany balances and transactions have been eliminated in consolidation.

Basis of Consolidated Financial Statements

The Organization's policy is to prepare its consolidated financial statements using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. That basis differs from accounting principles generally acceptable in the United States of America in that certain revenues are recognized when the services are provided rather than when earned and certain expenses are recognized when paid rather than when the services are received. Under the modified cash basis of accounting, related party receivables and payables are accrued. Accordingly, the accompanying consolidated financial statements are not intended to present the financial position and changes in net assets in conformity with accounting principles generally accepted in the United States of America.

Notes to Consolidated Financial Statements (continued)

Summary of Significant Accounting Policies (continued)

Financial Statement Presentation

The Organization reports information regarding its financial position and activities according to three classes of net assets:

- <u>Net Assets without Donor Restrictions</u> Net assets are not restricted by donor-imposed restrictions and are available for use in the Organization's ongoing operations.
- <u>Net Assets with Donor Restrictions</u> Net assets are limited as to use by donor-imposed restrictions that either expire by passage of time, can be fulfilled and removed by action of the Organization pursuant to those restrictions or are permanently restricted as to use and generally allow only the use of earnings for restricted purposes.

The net assets of the Organization are without donor restrictions at December 31, 2021 and 2020.

Use of Estimates

The preparation of consolidated financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the consolidated financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Liquidity and Available Resources

The FOP has \$2,088,279 of financial assets available within one year of the balance sheet date to meet cash needs for general expenditure consisting of cash. None of the financial assets are subject to donor or other contractual restrictions that make them unavailable for general expenditure within one year of the balance sheet date. The FOP has a policy to structure its financial assets to be available as its general expenditures and liabilities come due.

Notes to Consolidated Financial Statements (continued)

Summary of Significant Accounting Policies (continued)

Property and Equipment

Property and equipment are carried at cost. Depreciation is calculated using accelerated or straight-line methods over the estimated useful lives of the respective assets. Assets purchased but not placed in service are capitalized and depreciation is not recorded until the assets are placed in service. Property and equipment that are donated are recorded at fair market value on the date of receipt. Maintenance and repairs, which do not improve or extend the estimated useful lives of the respective assets, are expensed as incurred. Major improvements or betterments are capitalized. When property and equipment are sold or retired, the related cost and accumulated depreciation are removed from the accounts, and any gain or loss is included in income. Property and equipment are depreciated over their estimated useful lives as follows:

Building and improvements	10 - 40 years
Office equipment	5 - 7 years
Computer equipment	3 - 7 years
Furniture and fixtures	5 - 7 years

Total additions during 2021 and 2020 were \$3,107 and \$27,062, respectively.

Impairment of Assets

The carrying value of long-lived assets is reviewed for impairment whenever events or circumstances indicate the amount of the assets may not be recoverable. When an indication of impairment is present and the undiscounted cash flows estimated to be generated by the related assets are less than the assets' carrying amount, an impairment loss will be recorded based on the difference between the carrying amount of the assets and their estimated fair value. There were no such impairment adjustments at December 31, 2021 or 2020.

Rental Revenue

Rental revenue is recognized when paid by tenants.

Federal Income Taxes

The FOP, 222 Corporation and FOPF are exempt from federal income taxes under Sections 501(c)(8), 501(c)(2), 501(c)(3) and 501(c)(3), respectively, of the Internal Revenue Code.

A provision, if applicable, has been made in the consolidated financial statements for federal income taxes by applying statutory income tax rates to income before income taxes.

Federal Income Taxes (continued)

The Organization accounts for uncertainty in income taxes in its consolidated financial statements as required under Financial Accounting Standards Board (FASB) Accounting Standards Codification, *Accounting for Uncertainty in Income Taxes.* The standard prescribes a recognition threshold and measurement attribute for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return. The standard also provides guidance on de-recognition, classification, interest and penalties, accounting in interim periods, disclosure and transition accounting. Management determined there were no material uncertain positions taken by the Organization in its tax returns.

Recent Accounting Pronouncements

In February 2016, the FASB issued ASU 2016-02, a new standard for both lessees and lessors. Under its core principle, a lessee will recognize the lease assets and liabilities on the statement of financial position for nearly all lease arrangements. The new standard is effective for annual periods beginning after December 15, 2021. Management is in the process of determining the effect of this change on its accounting and disclosure of lease activity.

Cash

Cash includes cash on hand and demand deposits held by banks. Cash is maintained in ten accounts at three financial institutions and, at times, balances may exceed federally insured limits.

Note Receivable - Related Party

From 1984 through 1986, the FOP rendered services totaling approximately \$97,000 on behalf of the OLC. In January 1997, a promissory note agreement was signed between OLC and FOP for \$97,493. The note agreement is payable by OLC in annual payments of principal and interest of \$1,000 beginning July 1997 and through July 2097. The note has been recorded in the accompanying consolidated financial statements at its present value of \$12,082 and \$12,085 at December 31, 2021 and 2020, respectively, using an interest rate of 8.25%.

Long-Term Debt

222 Corporation entered into a term note payable in the amount of \$632,408 with a financial institution in December 2017 which is secured by the property. Monthly payments of principal and interest in the amount of \$4,758 were due through December 2032. During 2019, 222 Corporation began making biweekly payments of \$2,379 on the note payable. Interest is calculated at a fixed rate of 4.25%. Outstanding borrowings on the note at December 31, 2021 and 2020 were \$484,364 and \$526,258, respectively.

Accounts Payable - Related Party

Accounts payable – related party consists of overpayments of amounts owed by FOP to OLC for rent, personnel, postage, computer usage and other charges under a service agreement.

Leases

The Organization leases office space to the OLC and other unrelated parties under operating lease agreements. The lease terms expire at various dates through 2023. The leases include a monthly base rent and a portion of the Organization's operating expenses, as defined in the agreements. Effective January 1, 2020, the lease with OLC was extended until December 31, 2029. Initial monthly payments from OLC are \$4,081 and will increase 2% each year until maturity.

Labor Agreement

Approximately 31% of FOP's employees are covered by a collective bargaining agreement that expires in December 2023.

Retirement Plan

The Organization has a salary reduction plan (401(k) Plan) for substantially all full-time employees who have attained the age of 18 and completed six months of continuous service. Contributions are held for the exclusive benefit of the employees. Annual contributions by the Organization to the 401(k) Plan are discretionary. Contributions of \$6,434 and \$7,287 were made in 2021 and 2020, respectively.

Related Party Transactions

In addition to the office space described above, the Organization leases certain office equipment and furniture to the OLC under annual operating leases. Total rental income received from OLC in 2021 and 2020 was \$58,342 and \$57,448, respectively.

The Organization provides various administrative and technical services to the OLC under a service agreement, which extends through July 2027. During 2021 and 2020, the Organization received management fees of \$273,692 and \$281,248, respectively, from the OLC. Additionally, expense reimbursements of \$569,223 and \$474,882 were received from OLC during 2021 and 2020, respectively.

Subsequent Events – Date of Management's Evaluation

Management has evaluated subsequent events through the date of the Independent Auditor's Report, the date on which the consolidated financial statements were available to be issued.
