






#### In Memoriam



After a patriotic stint in the US Army, spending time in Okinawa and Korea in combat engineer, he spent his entire working life with Ohio Edison in Akron. A dedicated "company man" he retired in 1994. He was very proud of his volunteer time with the Fraternal Order of Police Associates, Akron Lodge 6 and served as its president for 25 years. Thank you to the Akron Police for the friendship offered over the years. # State Secretary-Treasurer Report

Happy Fall, from your Secretary-Treasurer!

I hope this finds everyone well. While things have slowed with the per capita payments, we need to make sure that everyone has sent in their final payment and list of paid members. It is VITAL that all the names of the paid members for 2022 be sent in – if you do not submit this list, there could be a chance that a paid member does not have a card printed for the 2023 membership year. We take the paid member list from the current year and submit those to the printer for the next membership year. If your paid member's name is not submitted, he/she will not have a card for 2023. Therefore, it is *IMPERATIVE* that this list be submitted by month's end.

If any lodge has questions regarding this issue, please do not hesitate to contact our administrator, Denise Young, or myself.

In addition to the names being submitted, please submit your final per capita payment. Your membership list and per capita paid, must match. Again, please submit your final per capita payment by month's end as well.

The Fraternal Order of Police of Ohio is the largest law enforcement organization in the State of Ohio, with more than 22,000 active and retired members in the Buckeye State.

In May of 2022, a poll conducted by Morning Consult showed that a vast majority of registered voters—81%—describe crime as a significant problem in our country. Crime and personal safety are a top concern of 79% of these voters. This poll also revealed that 61% of these voters would rate the performance of police in their communities as excellent or good, and 3 in 4 of the voters surveyed agree that police officers do their jobs regardless of skin color, gender, or other factors. The poll also showed that 72% of registered voters trust organizations "like the Fraternal Order of Police a lot or some," and 43% of these voters say knowing a nominee or candidate for office has the endorsement of the FOP makes them more likely to support them.

The Fraternal Order of Police of Ohio and its local lodges endorse the following candidates for the Ohio House of Representatives and the Ohio Senate. "Our endorsed candidates have shown a strong commitment to supporting issues important to municipal, county, and state law enforcement officers across our state," said FOP of Ohio President Gary Wolske. "We will encourage our members and the citizens of Ohio to support the candidates endorsed by the FOP of Ohio," Wolske said.
