Greetings Brothers & Sisters!

I would like to welcome you to our First Edition of the State FOPA Newsletter! I hope you find this information useful. Please use this as another tool that the State FOPA is providing to help your Local Lodges get your message out to the masses. Also, our Facebook page is a great way to promote your fundraisers, stories, and photos to other members who may not otherwise know what you are doing. #MOVEOVER This hashtag should be familiar to all FOPA members in the State of Ohio. You might be asking "WHAT IS A HASHTAG"? Frankly, I had to ask my daughters to explain. They broke it down to simply mean a number sign followed by a group of words that is link to a message about a topic on the internet, social media, or at times in real life. **#MOVEOVER** is the hashtag for the Ohio FOP Move Over Campaign. This campaign is to 1) raise awareness of Ohio's current move over law and 2) to stiffen the penalties of that law. Despite the fact that the **#MOVEOVER** law has been in effect for over 10 years, numerous injuries and fatalities continue to occur. Under this law the penalty is a possible fine and possible suspension of driving privileges. Under the new proposal changes would include upgrading the charge to a misdemeanor, drivers could be jailed up to 180 days, and fined up to \$1,000 if someone is hurt or killed.

There are 2 components to the **#MOVEOVER** campaign. First, is education of the current law which requires a motorist to move over on a road or highway that has 2 or more lanes. If that is not possible, the driver must SLOW DOWN to a safe speed while passing the emergency vehicle. Secondly, is to move legislation so that when the law is broken proper punishment will be able to be handed down. This will reduce the number of crashes that are injuring, dismembering, and killing first responders in Ohio. What can you do as an FOPA Members? Tell your family and friends, share the **#MOVEOVER** on your social media, write a letter to your State Representative & State Senator, and most importantly **#MOVEOVER**!

The 2018 State Conference will be held on June 21 – 24 in Independence, Ohio. John Chesar and I met with 2 hotels in Independence in regards to our Conference. In years past, we stayed at the Crown Plaza across the street and had to shuttle, drive, or walk across the street to the activities. This was a major inconvenience and a safety concern. I am happy to announce that next year our lodging will be at the Spring Hill Suites by Marriott next to the Holiday Inn and our meetings will be held at the Holiday Inn with the FOP. This should further build the FOP/FOPA relationship that is growing. The rate will be \$125 per night. You cannot book a room until NEXT SPRING! I am putting the rate info out there so that you can start planning for your conference budget now. Also, I hope to see you there!

Our featured member this issue is 2017 FOPA Member of the Year Rick Grane. Rick is a 25-year member of Western Cuyahoga Lodge #28 located in Westlake. He has served his lodge for two of those years as their vice president and the past 16 years as their sergeant at arms. Lodge #28 is a very active lodge and Rick said he enjoys many of their events including their annual reverse raffle, a yearly cook out, and shop with cops for which he really gets into the Christmas spirit and dresses as an elf! According to Lodge 28 secretary Becky Woodward, 'You haven't lived until you see Rick in an elf costume!' He bartends their annual Murder Mystery Dinner and orders all of the food for their cook out and Christmas party. He doesn't just pick up the food, cook, and clean up. He also makes sure leftovers get delivered to area police departments.

Rick is a widower with one daughter and like many FOPA members, he became involved with our organization to help police and to better serve his city. Rick lost his wife Susan to cancer in 2003 after a 16 year battle. He uses her as his strength and inspiration to give back to the community. His service to his community doesn't stop with the FOPA. He is active with The American Cancer Society's Relay for Life, the Historical Society, and he is the vice president elect of the Westlake Town Criers. He has served with the Westlake Police Auxiliary since 2005, volunteering around eighty hours a month, and has twice been Auxiliary Officer of the Year. Rick was named 'Mr. Westlake' in 2014, which is the citizen of

the year award for the city of Westlake.

He is also very active with the Kiwanis and has served three terms as their president. Currently Rick is working on a project with the Kiwanis raising funds for new canines for the Westlake Police Department. Thus far the project has raised almost \$25,000 within the Westlake community.

Lodge of the Year

Our first featured lodge is the winner of the 2017 FOPA Lodge of the Year award, Erie County Lodge 35. Located in Sandusky, they are the associate lodge to FOP Lake Erie Lodge 17. They currently have fifty-seven members. Although, they may not be one of the biggest lodges in the state they are one of the most active.

Lodge 35 not only hosts their own events and fundraisers, but they assist their 'P Lodge' with whatever they have going on. FOP 17 and FOPA 35 are an outstanding example of how an FOP lodge and their associate lodge should assist and support one another. They help their P lodge with their annual reverse raffle and the homemade desserts the FOPA provides for that evening are always a hit. Together they have hosted two formal galas and always help each other with fundraisers as well as raffle sales. When FOP 17 was chosen to host the 2017 FOP/FOPA summer conference, FOPA 35 was on board to help!

Their charity committee collects items at their monthly meetings for various organizations in Erie County. These items include: Easter basket items for less fortunate children, items for use by Safe Harbor to help local victims of domestic violence, supplies and food for the Erie County Dog Pound, toys during the holidays for Toys for Tots, school supplies each school year, and food donations for a local soup kitchen. Along with FOP 17, they brave the elements to raise money for Special Olympics at their annual Polar Plunge. Some of FOPA 35's male members strut their stuff in red high heels to support Walk a Mile in Her Shoes. Several of their members have, for the past few years, donated their time to help the Salvation Army with community feeds.

Lodge 35 has a vest fund to help local part time and reserve police officers pay for their vests. They also have a scholarship program for their members, their

children and grandchildren. Some members travel to Washington DC each year along with members from FOP 17 for National Police Week to honor those officers that made the ultimate sacrifice. The members that didn't make the trip this year, started a Blue Ribbon campaign. Blue ribbons were placed all around the community and at local businesses for Police Week, raising community awareness and showing support to their local law enforcement.

The funds they raise never sit idle for long. Each month they receive requests for donations from other organizations throughout Erie County. They do their best to accommodate each request with either their time, providing a basket to raffle, or a monetary donation. Just this month you will find them giving away a pair of bicycles at National Night out, Participating in Walk a Mile, and helping their FOP with a fundraiser on Put-in Bay.

Thank you FOPA 35 for all you do and congratulations on being named 2017 FOPA Lodge of the Year.

Trustee Gregory

August 11, 1955 – July 14, 2017

Colonel Reverend Doctor Everett Lloyd Gregory was born on July 14, 1955 in Middletown, Ohio to Mrs. Evernolia & Mr. Emmett L. Gregory and passed away from lung cancer at Hospice of Cincinnati, Blue Ash on July 14, 2017.

Dr. Gregory graduated from Middletown High School in 1979 had a Bachelor's Degree in Engineering from Central State University, Bachelor's Degree in Communication Engineering from A&T University, Masters in Business from Xavier University, and Doctorate degree in ethics/ divinity from Kentucky College of Contemporary Religion. Dr. Gregory was a Colonel in the Ohio Military Reserves where he was a Chaplain. He was very active in the Cincinnati area as he was involved in many organizations. Dr. Gregory was a Small Business Development Advisor of Veterans with the Ohio Small Business Development Center. Dr. Gregory also was the Chaplain of Queen City Lodge #4 and the State Trustee for the 9th District.

Dr. Gregory was respectfully a friend, brother, counselor, and parent. Everett devoted his life and energies to education, citizenship in the finest tradition with a love for this great Nation, a dedication and passion for excellence in all that he did. We are one great and diverse Nation under God and Dr. Gregory lived these beliefs with all his heart, soul, efforts, and energy.

Dr. Gregory leaves to cherish his memory two daughters Kara Gregory and Dymond Small, three sisters: Elaine L. Garrison, Eleanor L. Gregory, and Eugenia L. Jordan; three brothers Dr. Louis L. Gregory, Eric L. Gregory (LiSu), and Elliott L. Gregory, a special beloved friend, Teisha Smalls, and a host of nieces, nephews, other relatives and many friends. He received the FOPA Burial Ceremony at his funeral. Which was held on Saturday, July 22, 2017 in Middletown, Ohio.

Dr. Gregory lived a life full of giving to his family, community, friends, and Nation. Although his life was cut short he touched each and every person he came into contact with in some way. His career choice was to assist Veterans develop, start, and grow their own businesses. He was their Chaplain in their times of need. He will be truly missed.

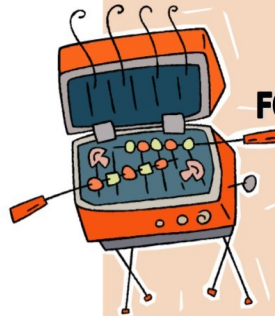
