## FOP Demands Online Fundraising Platform St.

FOR IMMEDIATE RELEASE May 5, 2025

#### OHIO FOP DEMANDS GOFUNDME REMOVE FUNDRAISER FOR COP-KILLER WHO TAUNTED DEPUTIES AT ARRAIGNMENT

CINCINNATI, OH – Ohio FOP President Jay McDonald demanded that the online fundraising platform GoFundMe immediately remove multiple fundraisers supporting Rodney Hinton Jr., the man charged with intentionally murdering a Hamilton County Sheriff's Deputy on May 2<sup>nd</sup>. Hinton's son was killed by Cincinnati police the previous day after pointing a loaded semiautomatic handgun at a police officer during a foot chase.

"Rodney Hinton Jr. intentionally murdered a recently retired deputy who was working special duty at a graduation just because he was a police officer," Queen City FOP 69 President Ken Kober said. "His heinous and cowardly act shouldn't be rewarded and celebrated like it is right now by GoFundMe. On behalf of all law enforcement officers, we demand that GoFundMe stop honoring and profiting from a cop-killer who taunted deputies about the murder at his arraignment."

"This is absolutely outrageous, to fundraise off the assassination of a law enforcement officer. The 23,000 members of the Fraternal Order of Police of Ohio demand that GoFundMe take these appeals down immediately," said FOP of Ohio President Jay McDonald.

More than a <u>dozen</u> fundraisers for Rodney Hinton Jr. are currently active on GoFundMe. The most <u>active</u> has raised more \$5,000.

Worse yet, GoFundMe has removed and/or made it difficult in the past for funds to be raised for cops killed in the line of duty. To allow fundraisers for a cop killer is just over the line.

The Fraternal Order of Police of Ohio is the state's largest law enforcement organization representing police officers at the local, county, state, and federal level.

On June 24, 2024, Carroll County Sheriff's Deputy Ken Wohlheter responded to a well-being check on an individual just outside the Village of Minerva.

When Deputies arrived, the subject of this well-being check opened fire on them with an AR-15 rifle and a 12-gauge shotgun.

Deputy Wohlheter was within inches of being struck in the head from this gunfire and was able to take cover behind his patrol vehicle. As the rounds were beginning to penetrate the cruisers, Deputy Wohlheter had the presence of mind to take command of the situation and direct his fellow Deputies to cover, thus preventing them from being struck before tactical units arrived with armored vehicles.

Deputy Wohlheter maintained discipline and composure under fire as he aided his fellow Deputies with life saving tactics to keep them from being killed or seriously injured from this barrage of gunfire.

Deputy Wohlheter is truly a hero.

## Preliminary Qualified Immunity Plan

Proponents of eliminating Qualified Immunity need 413,487 valid signatures from at least 44 counties and are aiming for the 2026 ballot. They have not filed a campaign finance report, indicating that they have not raised substantial revenue. They do not have an established group with political muscle backing them as of now.

#### Follow the playbook from Senate Bill 5

- 1. **Build coalitions** Unions; Police and Fire groups; Mayor's Alliance; elected officials and others have all reached out to work with us to defeat proposal
- **2. Engage Experts** Communications Counsel and Bob Paduchik remain on our team
- · Lodges should be building social media; gathering emails/phone numbers; begin to think about financial resources; making sure members are registered to vote
- 1. FOP of Ohio War Chest has funds that have been building since SB 5
- 2. FOP of Ohio will begin Social Media Efforts to build more followers
- 3. FOP of Ohio will work with local lodges to build bigger email/app database
- **MESSAGING**: Until we get direction saying otherwise informed by polling/testing, we are using:
- \* Eliminating Qualified Immunity will raise taxes, increase crime and devastate the number of people willing to serve their community.
- \*Eliminating Qualified Immunity hurts not just law enforcement, it targets those who educate our children, care for our elderly, and all other public employees

- · To members, tell how it impacts them so they understand the risk
- · To the public and on our social media/in press, laser focus on how it impacts the community as a whole and not on us

On May 3, 2025, the Board of Trustees voted unanimously to begin the process of ending the marketing relationship the FOP of Ohio has with Thin Blue Line Benefits. On May 5th, an email with delivery confirmation was sent to give 30 days notice of the cancellation of our agreement, as required by the agreement.

The Ohio Police and Fire Pension Fund issued the following letter about Thin Blue Line Benefits:

**OP&F** offers guidance to Thin Blue Line members

OP&F has had calls from retirees who are concerned with Thin Blue Line health care, which has plans available to pre-Medicare members. As members may recall, this plan is part of the "open HRA" which pre-65 members specifically requested so that they could make their own health care decisions based on their personal circumstances. The concerns with Thin Blue Line are about non- payment of medical bills.

OP&F's Board of Trustees discussed the issues at their March and April meetings. The Ohio Fraternal Order of Police has indicated that they are working with Thin Blue Line on non-payment issues.

In order to change plans outside of open enrollment, a member would need a Special Enrollment Period. If Thin Blue Line has failed to pay any medical bills in 2024 or 2025, OP&F and Alight may be able to assist in obtaining a Special Enrollment Period notice that would allow Thin Blue Line members to change plans.

Please do not unenroll from Thin Blue Line insurance without receiving a Notice of Special Enrollment Period. Doing so may jeopardize your health care stipend. Contact Alight to inquire about a Special Enrollment Period.

OP&F continues to monitor if a Special Enrollment Period notice that allows Thin Blue Line members to change plans will occur. OP&F will still provide a stipend to members who receive the notice of special enrollment. Upon notice of a Special Enrollment Period, members have 60 days to enroll in another health care plan and will still be eligible for the balance of the OP&F stipend for 2025. In the meantime, members must direct their calls about non-payment to Thin Blue Line.

#### FOP of Ohio Legislative Report

The Ohio Senate now has HB 96/State Operating Appropriations for FY 2026-27 after it was voted out of the Ohio House of Representatives by a vote of 60-39. After receiving it from Governor DeWine, the House made hundreds of changes to the Budget. The Senate will make more changes, and if that happens, the bill will go to a Conference Committee, where an equal number of select senators and representatives will work on the differences between the Senate and House versions. Both chambers will have to accept the committee's work before the bill is sent to Governor DeWine, who will then make additional changes through line-item vetoes. As of this writing, the House version includes \$30M in fiscal year 2026 and \$35M in fiscal year 2027 for continuing police training. It requires state attorneys to represent state law enforcement officers in the use-of-force cases if the officer wants their services. And it allows recreational marijuana tax dollars to support law enforcement. The marijuana tax dollar language is a bit vague, however.

Capital City Lodge #9 President Brian Steel testified before the House Finance Committee on a provision in the Budget that would require parental approval for the use of certain applications. The provision did not make it into the Budget but was introduced as a stand-alone bill.

The Lodge continues to fight for our legislative priorities to be included in the Budget, such as the OPERS-LE service credit fix, OP&F employer contribution increase, arming of State special police officers, and OPERS-LE DROP.

Secretary Travis Parker testified on SB 114/Police Arrest and Ticket Quotas before the Senate Judiciary Committee, and I testified against HB 5/Enact the Repeat Offender Act before the House Judiciary Committee. It may seem odd that I testified against a bill titled Enact the Repeat Offender Act, but the bill lowered penalties on weapons with a disability. And after five years, records for most F-4s, F-5s, and misdemeanors would be sealed or expunged. Essentially, there would be very few career criminals.





Dear Mayor Malik,

As you know, civilian oversight boards of police departments are controversial, often politicizing public safety. Where oversight boards continue to operate, we believe maximum transparency and community involvement are key to positive outcomes. That includes the process by which members of the oversight board are selected.

A civilian oversight board exists to serve the public, not its own interests. We've learned that current Akron civilian oversight board members, notably Chairman Kemp Boyd, seek to participate in the interview process for new candidates for appointment.

This process is supposed to involve the people, not the existing oversight board members. That's why the charter gives the responsibility of making appointments to the City Council and you as mayor. You are elected by the people and are, therefore, accountable to the people. The board isn't accountable to the people and may, therefore, have a very different vision, which shouldn't be layered into the appointment process.

We understand that the city council has exercised its right to undertake the appointment process without the board's involvement but that you intend to do your own process, including Chairman Boyd. We understand this might slow down the process and add multiple interviews because of the different processes undertaken. We further understand that Akron FOP Lodge #7 asked to join the process, but you refused. Surely, if you're interested in getting outside input from the board, outside input from the police would be just as valuable.

We cannot help but notice a disconnect between your rhetoric and actions. You speak about how public safety is your top priority. Yet, you consistently and unfairly target law enforcement, neglecting to defend your officers and refusing to include them in public safety discussions. The board was promoted as a means to bridge the gap between the community and the police department, but the divide has never been wider. Your actions undermine the very objectives you've communicated to Akron residents you wish to achieve.

For the civilian review board to be credible, its members must be chosen independently or with the full involvement of all interested parties.




